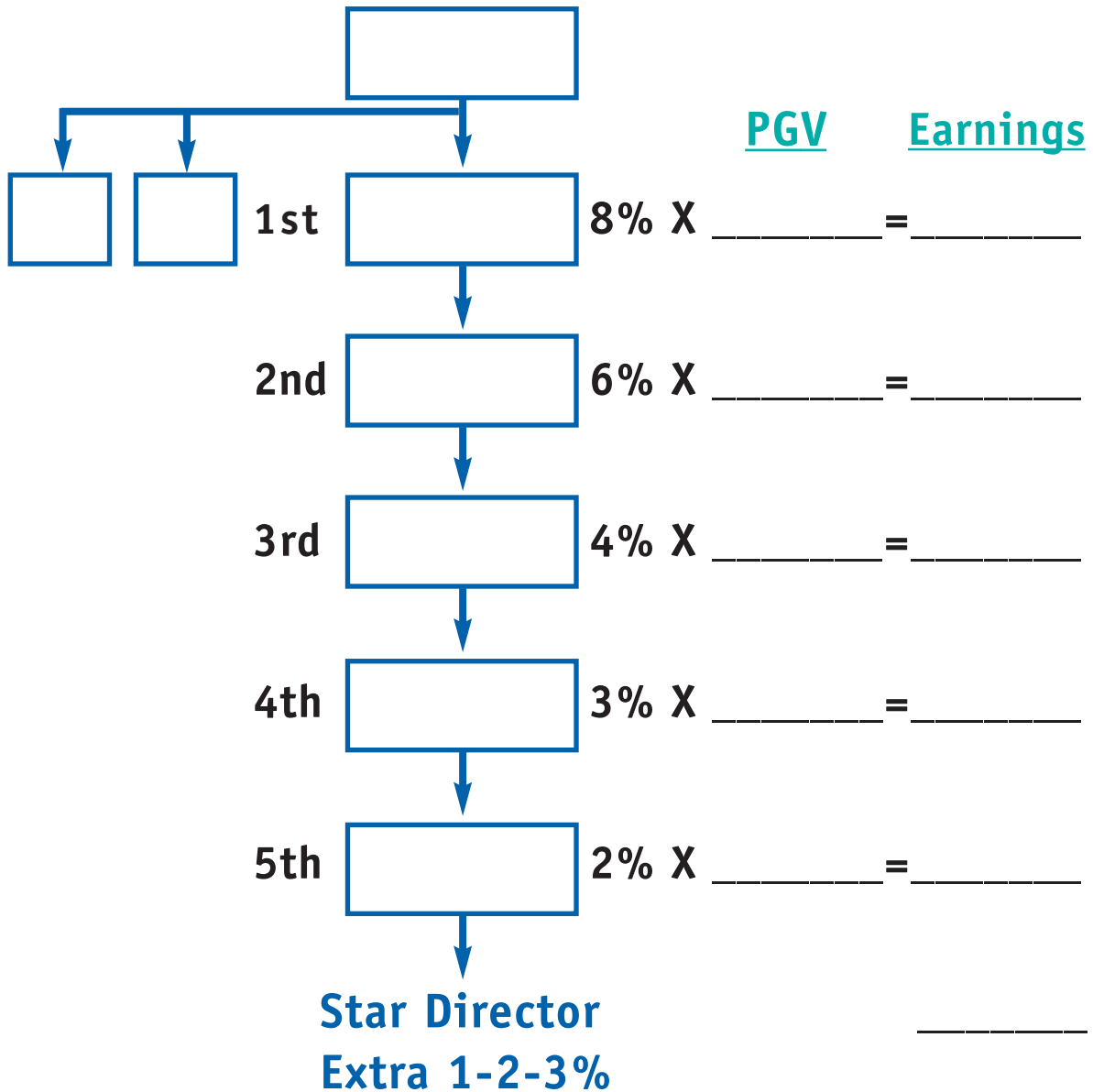
- The first avenue of income is **Retail Profit**.

2. Wholesale Profit: 5%–20%

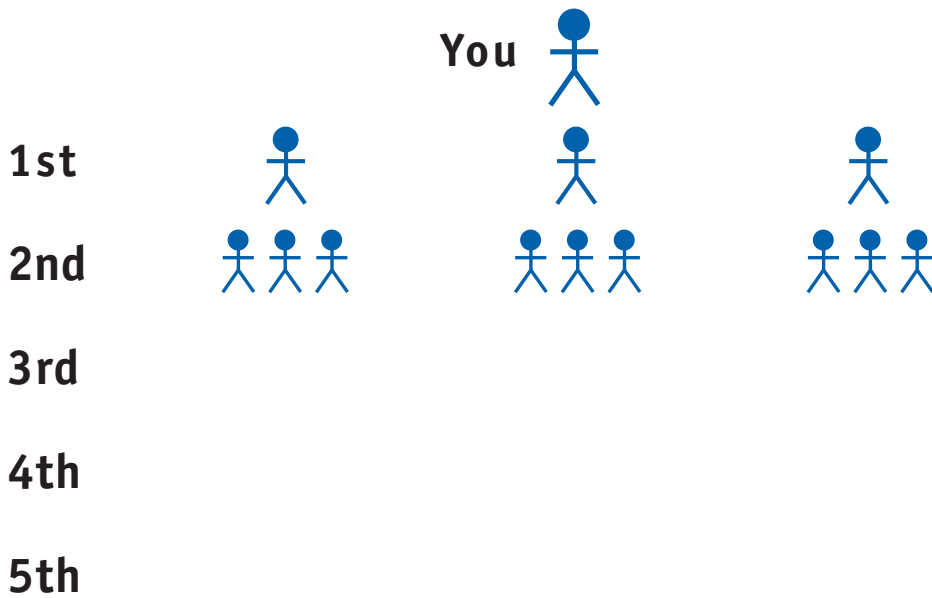


- The second avenue of income is **Wholesale Profit**; volume determines your profit level.

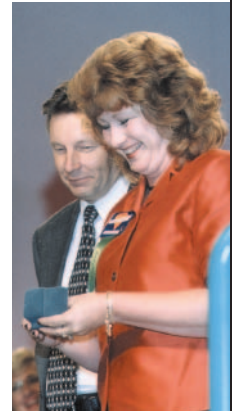

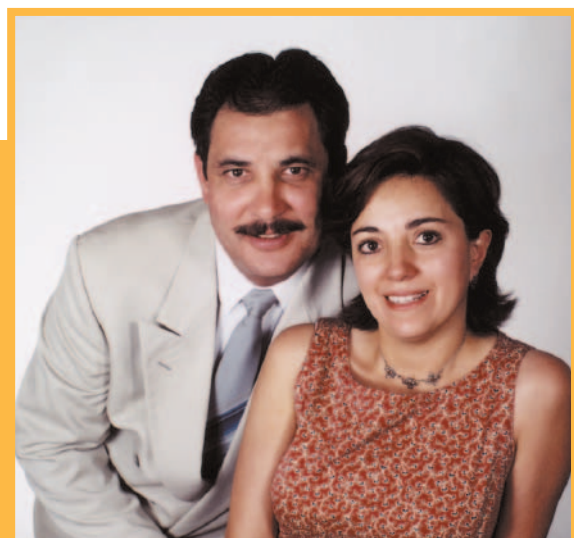

DISTRIBUTOR AGREEMENT

1. Upon acceptance of the foregoing application by Reliv Philippines, Inc. ("Reliv"), the person designated as an Applicant and signing this Application and Distributor Agreement ("Distributor") shall become an independent distributor for Reliv and shall be authorized for the term of this Agreement to purchase Reliv products, promote, sell and distribute such products, sponsor distributors and otherwise act as an independent distributor for Reliv in accordance with the terms hereof. Distributor agrees to use Distributor's best efforts to promote and sell Reliv products and to perform as an independent distributor of Reliv. Reliv has made Distributor aware that the Retail Trade Nationalization Law (Rep. Act No. 1180) prohibits non-Philippine nationals or citizens from engaging in retail trade within the Philippines and Distributor shall conform to such law.
2. Reliv agrees that it will use its best efforts to supply to Distributor, upon receipt of payment, all of Distributor's requirements of Reliv products as Distributor may order from time to time. Payment in full for all products purchased by Distributor from Reliv shall be due at the time of Distributor shall order such products. The purchase price for all products sold to Distributor by Reliv shall be in accordance with Reliv's published prices therefor and will be inclusive of VAT; Reliv reserves the right to change the purchase price for its products at any time by publishing such changes; all changes in price shall become effective at the time such price changes shall be announced or public by such means as Reliv shall determine.
3. This Agreement incorporates, and is subject to all of the terms set forth in the Reliv Distributor Guide and all Reliv publications to Distributors, including without limitation, the Reliv Distributor Policies and Procedures and the Reliv Compensation System, as they may be revised from time to time. Reliv reserves the right to amend, modify or change the Reliv Distributor Guide and any Reliv publication at any time or from time to time, by publishing the same to Reliv Distributors by such means as Reliv deems appropriate, and such changes shall become effective at the time of the publishing thereof. Distributor acknowledges that he or she has reviewed this Agreement and the Reliv Policies and Procedures and agrees to all of the terms and provisions thereof. If Distributor has not received a Reliv Distributor Kit, then the Distributor acknowledges that the Policies and Procedures are and have been accessible to review either upon request from Reliv and/or can be viewed at Reliv's website.
4. The term of this Agreement shall be for a period of one year from the date of this Application, subject to the right of Reliv to terminate this Agreement as provided herein. Distributor may renew this Agreement at the expiration of the initial term or any renewal term, in Distributor's sole discretion, by paying to Reliv the annual renewal fee within the time provided by Reliv for renewal. Reliv may terminate this Agreement and Distributor's status as a Distributor as of the expiration of the initial term or any renewal term, at its sole discretion, with or without cause, by written notice to Distributor given more than 30 days prior to the date of such expiration. Distributor may terminate this Agreement and Distributor's status as a Distributor at any time upon written notice to Reliv. Reliv may terminate this Agreement and Distributor's status as a Distributor at any time for cause, as provided in the Reliv Policies and Procedures. Upon the expiration or termination of this Agreement in accordance with the provisions hereof, all rights and obligations of Distributor and of Reliv hereunder shall cease and terminate, except rights or obligations accrued to the date of such expiration or termination and rights or obligations provided herein or in the Reliv Policies and Procedures to survive any expiration or termination of the Agreement, which rights and obligations shall survive any expiration or termination and shall continue to be binding upon the parties in accordance with their terms.
5. Distributor acknowledges and agrees that all information concerning Reliv distributors, including without limitation, names, addresses, telephone numbers, genealogies and other information relating to Reliv distributors, whether compiled or stated individually (hereinafter "Confidential Information") was obtained by Reliv at great effort and expense, is of great value to Reliv and is maintained by Reliv as confidential and proprietary information. Distributor further acknowledges and agrees that any Confidential Information received or obtained by Distributor, whether in the form of lists prepared by Reliv or other Reliv distributor, or otherwise, is received by the Distributor in confidence and on the condition and agreement that Distributor shall maintain such information as confidential. Distributor agrees that Distributor shall not disclose any Confidential Information to any person except as may be expressly authorized by Reliv in writing and shall not use any Confidential Information for any purpose other than the performance of Distributor's functions and duties as a Reliv distributor. Distributor further agrees that, during the term of this Agreement, and for a period of 18 months from and after the expiration or termination hereof, he or she shall not, directly or indirectly, solicit, recommend, suggest or induce any Reliv distributor to become a distributor for, or otherwise become associated with, any person or entity other than Reliv engaged in the business of marketing or selling any product or service by means of any direct sales, network marketing or multi-level marketing method or organization. All rights and obligations of this paragraph shall survive any expiration or termination of this Agreement.
6. This Agreement, which incorporates the Reliv Distributor Policies and Procedures, shall be governed by, and construed in accordance with the laws of the Republic of the Philippines. Any and all disputes arising out of or related to this Agreement, or between Distributor and Reliv or any other Reliv distributor shall be resolved and determined by arbitration in accordance with rules provided in the Reliv Distributor Policies and Procedures.
7. Distributor represents to Reliv that (i) all of the information provided by Distributor in this Application and Agreement is complete and correct and (ii) that Distributor has read and understands this Agreement and the Reliv Distributor Guide and accepts and agrees to all of the terms contained herein and therein. This Agreement constitutes the entire agreement among the parties and supersedes all prior written or oral representations, inducements, contracts or agreements among the parties.
8. This Agreement shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors in interest and, to the extent permitted herein, their assigns.
9. Whenever possible, each provision of this Agreement shall be interpreted in such manner as to be effective and valid under applicable law. If any paragraph of this Agreement shall be unenforceable or invalid under applicable law, such provision shall be ineffective only to the extent and duration of such unenforceability or invalidity and the remaining substance of such provision and the remaining paragraphs of this Agreement shall in such event continue to be binding and in full force and effect. No failure by a party to exercise any of such party's rights hereunder or to insist upon strict compliance with respect to any obligation hereunder, and no custom or practice of the parties at variance with the terms hereof, shall constitute a waiver by any party to demand exact compliance with the terms hereof. Waiver by any party of any particular default by any other party shall not affect or impair such party's rights in respect to any subsequent default of the same or of a different nature, nor shall any delay or omission of any party to exercise any right arising from any default by any other party affect or impair such party's rights as to such default or any subsequent default.
